ADDITIONAL TERMS OF SERVICE

1. Somerset Owners Association offers Advertisement for information purposes only. The purpose is to allow Advertisers to promote their products, services, and business to Somerset and other Reno residents.
2. Any claim(s) made by the Advertiser is (are) strictly his/her own. The Association does not guarantee, endorse, promote or vouch for the quality, efficacy or fitness for purpose of any products or services advertised nor does it assume any responsibility or liability for claims or statements made in the Advertisement.
3. The following types of Advertisement or content within a website or print material is prohibited:
 - a. Political (including federal, state, and local candidates and elected officials, political action committees and issue advocacy; candidates and elected directors for Somerset Owners Association and Sierra Canyon board positions and Association ballot questions)
 - b. "Adult businesses" as that term is defined in Chapter 18.09.303 of the Reno Municipal Code.
 - c. Discriminatory on the basis of race, religious creed, color, national origin, disability, sexual orientation, gender identity or expression, ancestry, familial status or sex.
 - d. Obscene, lewd, lascivious, profane, threatening, or violent.
 - e. Other types of Advertisement may be subject to additional Board approval.
4. The Board, in its sole discretion, may determine what constitutes prohibited content. Upon determination that an Advertisement contains prohibited content, Somerset Owners Association may remove the advertisement, images, links, etc.
5. The Association reserves the right to refuse or cancel an Advertisement for any reason or no reason.
6. The refund policy is as follows:
 - a. Termination of Advertisement for a violation of its content policy (see #3 above), no refund.
 - b. Advertiser elects to terminate Advertisement prior to end of term, no refund.
 - c. Board elects to terminate Advertiser for other than a violation of its content policy, pro-rated refund.
 - d. Board decides to terminate Advertisement program, pro-rated refund.
 - e. Somerset Owners Association website is non-functional for a period of 30 consecutive days or more, pro-rated refund or credit as determined by the Board.
